BASES OF THE CALL

1. Scope:

The purpose of the present bases is to regulate the granting of prizes, within the framework of the Chair in Mobility financed by thyssenkrupp, to Master's Thesis (TFMs) of University Masters completed at the University of Oviedo that were presented during the academic years 2015 -2016 and 2016-2017.

The Master's Thesis must be related to at least one of the following topics:

- New concepts for light structures
- New concepts of motors and transmissions
- New systems for control and signals
- New energy efficiency concepts
- Advanced concepts of passenger transportation systems
- Advanced manufacturing concepts
- Innovative applications of virtual environments
- Application of new materials in passenger transportation systems
- Smart data acquisition and data analysis. Safe communication
- Computer vision systems

2. Beneficiaries and participation requirements.

The beneficiaries of these awards will be those students of the University of Oviedo who have presented their TFM during the academic years 2015-2016 or 2016-2017 in some University Master's degree taught at the University of Oviedo. The work must be related to one of the themes indicated in the previous section.

Candidates must not be involved in any of the prohibitions established in art. 4.2 of the Resolution of April 9, 2010.

3. Endowment and financing

- a. The prizes, sponsored by thyssenkrupp with charge of the Chair in Mobility of the University of Oviedo, will have a global endowment of 3,000.00 Euros.
- b. Prizes will be awarded to three TFMs as detailed:
 - A first prize of fifteen hundred euros (1,500.00 €) plus certificate.
 - A second prize of one thousand euros (1.000,00 €) plus certificate.
 - A third prize of five hundred euros (500,00 €) plus certificate.

c. The payment of the prizes will be managed by the Foundation of the University of Oviedo.

4. Compatibility or incompatibility with other awards.

These awards are incompatible with other prizes previously received for the same TFM, coming from any public or private administrations or entities, national, European Union or international organizations

5. Form, place and deadline to submit the applications.

1- Applications for these awards have to be submitted duly completed, as per the application form in Annex 1, and must include:

- Personal data of the student.
- Copy of the document of the TFM submitted to evaluation at the University of Oviedo.
- Summary of the submitted TFM. This abstract should not exceed 2,000 words and may incorporate drawings and explanatory tables.
- Official academic certification of the Master University studies, indicating the qualification obtained in the TFM.
- Authorization to make notifications by e-mail (Annex II).

2- All the documentation can be presented in Spanish or English language

3- The deadline to submit the applications starts from the following day of the publication of this call on the website of the FOU until July 31, 2017.

The applications have to be addressed to the Foundation of the University of Oviedo, by any of the following ways:

4- The Foundation will review the applications received and check that they contain the required documentation. The provisional list of applications admitted and excluded will be published on the website of the FOU, indicating the cause in case of exclusion, granting the applicants a period of 3 days to submit allegation or remedy the defects for which they were excluded.

After this deadline, the final list of admitted and excluded applications in the selection process, will be published, indicating the appeals against it in the before mentioned website.

If all applications meet the requirements, the publication of the provisional list may be omitted.

6. **Instructions, resolution and terms for the award of prizes.**

The jury will make a concession proposal which will include at least the list of the scorings obtained by the different applications and awarded TFMs.

Once this proposal has been received, the Foundation of the University of Oviedo will issue the Resolution of granting the awards within a maximum period of 5 days from the proposed Resolution of the jury. Applicants whose proposals have been selected to receive one of the awards of the Chair in Mobility will receive the corresponding notification by email within a maximum period of 5 days from the following day of the publication of the Resolution of their concession.

The beneficiaries will have a period of 5 days from the following day of the receipt of the electronic notification made by the Foundation of the University of Oviedo, to communicate by email their acceptance or waiver of the prize.

The jury reserves the right not to award any of the prizes if the theses fail to meet the required merits.

The payment of the prizes will be endowed by bank transfer.

7. **Evaluation criteria:** Prizes will be evaluated accordingly to the following criteria:

- Grade of adaptation of the TFM to the "Areas of Interest" included in this call: 50% of the final assessment.
- Originality and relevance of the results of the carried out work: 30% of the final evaluation.
- Qualification granted to TFM: 20% of the final evaluation.

Prizes will be awarded to applications that achieve the highest scores.



8. **Jury:** The Valuation Commission will be integrated by: President: Director of the Chair in Mobility of the University of Oviedo, or person in whom he delegates. Members: Director of Cooperation with Business and Employability Department of the University of Oviedo, or person in whom he delegates, and three representatives of thyssenkrupp Elevator Center. Secretary: Managing Director of the Foundation of the University of Oviedo, or person in whom she delegates, with voice and no vote, that will guarantee the correctness of the procedure during the evaluation phase by the members of the Commission.

9. **Processing of personal data.**

The application for these awards implies acceptance of the contents of this terms and the authorization of usage of personal data by the Foundation of the University of Oviedo in accordance with Organic Law 15/1999, of December 13 on Data Protection of Personal character. The personal data provided will be incorporated in the user files, in accordance with the established in the aforementioned Organic Law.

10. **Acceptance of bases and rules of development.**

The participation in the call of the prizes regulated by these bases implies the full acceptance of them, corresponding to the Foundation of the University of Oviedo its interpretation and development.
